Dear Fellow Sowerby Resident

You will know from the media that the Department for Education is committing itself to provide more individual IT equipment to schools in the wake of the Covid pandemic and the current lockdown. It is extremely unlikely that this is going to filter down beyond Secondary Schools to Primary level.

Many pupils are unable to access IT at home for a variety of reasons and, especially during lockdown, this is causing problems within families. Lack of connectivity and wifi capacity only adds to the problem.

IT skills will be an essential tool for all children in the future and not to have access to the relevant equipment, especially during lockdown, is holding them back.

I have spoken to the head of Keeble Academy and we have come up with some great ideas.

### **Short term goals**

- Devices - so that our children can learn IT skills and get access to remote learning and resources
- Routers/dongles - for those families that cannot access internet
- Reading Books - more decodable early reading books. The situation for reading books is that no school has enough books for every child to have a few books at home to read (at their ability level) When they return these to school we need to quarantine these for several days so do not have enough books to send home a new selection straight away.
- E books - E books from very reputable publishers eg. Collins for those with internet to access to have books to learn to read

### **Long term Goals**

Laptop devices and charging trolleys to move around classes so all classes could get access to IT for developing skills for future life chances.
